Overview

This role will work exclusively with the Texas Women's Healthcare Coalition, supporting Medicaid policy work and Medicaid and state-funded family planning programs throughout the state to further increase access to contraception and preventive women's health services. This position will spearhead complex administrative advocacy work for the Coalition. This role will also work to develop relationships with Medicaid managed care organizations (MCOs) to further support women's health programs. The position will be responsible for identifying needs and developing and delivering training and technical assistance to Women's Health Providers and MCOs.

Roles and Responsibilities

- Identify training and technical assistance needs of women's health providers and support the transition of Healthy Texas Women Program into Medicaid Managed Care, among other transitions that may occur
- Develop and deliver trainings and materials supporting the transition of the Medicaid program to prevent barriers to access and care for Texas women
- Develop and maintain relationships with statewide associations, community groups and other key partners, Health and Human Services Commission staff, MCOs, policymakers and their staff
- Monitor and advise Coalition Director and Chair on administrative agency policies on Medicaid, family planning programs and women's preventive healthcare
- Analyze highly technical policy issues and distill for public facing audiences in an accessible manner
- Work with Communications Manager to develop external training materials and support coalition events
- Draft policy analyses, testimony and comments, presentations, and other publicfacing materials
- Assist with preparation for Coalition meetings, events, and legislative visits
- Support Coalition subcommittees, including Provider Workgroup and HHSC troubleshooting meetings



- Draft agendas, minutes, and other meeting or event materials as needed to support subcommittees
- Outline, track, and maintain progress on grant contract deliverables and draft grant reports for programmatic area
- Represent Healthy Futures of Texas and the Texas Women's Healthcare Coalition in the community in a professional manner

- Bachelor's degree or experience with a documented record of the ability to perform duties and responsibilities of the position
- At least 3 years of experience working in Medicaid policy or direct experience billing Medicaid for family planning services
- Experience in coalition or community work with multiple, sometimes conflicting, stakeholder groups
- Critical analytical skills to understand the political, social, financial, and external issues affecting women's health providers; ability to foresee and interpret trends and the changing needs of TWHC members and to develop processes and resources to respond effectively and in a timely manner
- Strong organizational skills, including the ability to work independently and manage own projects in a fast-moving environment
- Excellent presentation/public speaking skills
- Excellent verbal and written communication skills
- Proficiency in MS Office Suite and Google Suite and the ability to learn new software as needed
- Exceptional interpersonal skills to advance of TWHC's mission and vision both internally and externally, and to respond diplomatically to challenging issues
