Overview

The Director of Foundation Relations supports Healthy Futures of Texas' strategic priorities and financial needs by securing and reporting on grants from foundations. Reporting to the Chief Development Officer, this individual plays a key role in developing department goals, priorities, and direction. A frontline fundraiser, the Director of Foundation Relations writes compelling proposals, manages deadlines, researches/cultivates prospects, and stewards donors. Utilizing excellent written, oral, and interpersonal communication skills, this individual works collaboratively with internal and external stakeholders in building relationships, developing budgets, and securing critical funding.

Roles and Responsibilities

- Serves as the project manager for grants—including, but not limited to developing proposals submitting funding requests, writing evaluations, building relationships with funders, managing the coordination of the approval, application, grants management assignment and reporting process, and tracking all grant activity in an organized manner, including application and reporting deadlines.
- Working with the Chief Development Officer, sets goals/objectives and executes annual strategy to secure and manage significant grant-based institutional fundraising (approx. \$3 million).
- Personally manages a portfolio foundation prospects, developing individualized strategies for institutional prospects and donors, and providing regular updates on the Healthy Futures of Texas' progress and impact.
- Builds internal relationships with colleagues across the organization and develops a deep understanding of Healthy Futures of Texas' programs, priorities and areas of future growth to identify strong matches with potential funders.
- Maintains contact records and tracks grant proposal progress, generating reports to make it possible to regularly reconcile grant proposal status and revenue with the finance team and to track performance to the development plan.
- Works collaboratively with other members of the development team. Actively participates in and aids in the planning of other fund development initiatives, including special event fundraisers, traveling to those Texas cities where those events are held when necessary.
- Participates in organization wide events and programs, including those held on evenings and weekends and those that necessitate travel (within Texas).
